(Under Section 803 of the Not-for-Profit Corporation Law)

The undersigned, being the president, does hereby certify pursuant to Section 803 of the Not-for-Profit Corporation Law, as follows:

- 1. The name of the Corporation is the Young Mens Christian Association of Middletown, N.Y..
- 2. The Certificate of Incorporation which is the subject of this Amendment was formed by legislative act and filed with the Secretary of New York State on June 1, 1883.
- 3. The paragraphs of the aforesaid Certificate of Incorporation which are affected by this Certificate of Amendment are as follows:
  - a. The name of the Corporation is amended to be the "Young Men's Christian Association of Middletown, N.Y.".
  - b. That paragraph within the aforesaid Certificate of Incorporation defining the purpose of the Corporation shall be and hereby is amended to read in its entirety as follows:

"Ithe Undersigned Citizens of the United States and residents within the State of New York desire to associate ourselves together for benevolent, charitable, missionary and literary purposes; and for the purpose of munual improvement in religious knowledge and for the furtherance of religious opinion, and for the mental, moral and spiritual

improvement of men and women; and for the purpose of providing school age day care services. These day care services shall be provided at a school-age child care program providing child care before and after-school only for children in the County of Orange for up to but not more than three hours in the morning and three hours in the afternoon of each day. However, nothing in the Corporation's Certificate of Incorporation shall authorize the Corporation to establish or operate day care centers as defined in Section 390 of the Social Services Law without obtaining prior approval of the New York State Department of Social Services."

c. A new paragraph within the aforesaid Certificate of Incorporation is intended to read in its entirety as follows:

"[n]otwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(a)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law)".

- 4. The Secretary of State is hereby designated as an agent of the corporation upon whom process against it may be served. The address to which the Secretary of State shall mail a copy of such process is as follows: Middletown YMCA, 81 Highland Avenue, Middletown, New York 10940.
- 5. The manner in which this Amendment of the Certificate of Incorporation was authorized was by the affirmative vote of a majority of the members of the Corporation entitled to vote thereon at a special meeting of the members held on the 19th day of November, 1996. The affirmative special vote being at least equal to a quorum.

- 6. The Corporation is a Corporation as defined in Section 102(a)(5) of the Notfor-Profit Corporation Law; the Corporation is a Type B Corporation as defined under
  Section 201(b) of the Not-for-Profit Corporation Law.
- 7. No approvals or consents were endorsed on or annexed to the Certificate of Incorporation as defined in Section 102(a)(3) of the Not-for-Profit Corporation Law. The approvals of a Justice of the Supreme Court, and the Chairman of the National Board of the Young Men's Christian Association will be annexed to this Certificate of Amendment of the Certificate of Incorporation of the Young Mens Christian Association of Middletown, N.Y. prior to the delivery of this Certificate of Amendment to the Department of State of the State of New York for filing.

This is in response to your request for a letter affirming your organization's exempt status.

In September 1943 we issued a determination letter that recognized your organization as exempt from federal income tax under section 101(8) of the Internal Revenue Code of 1939 (now section 501(c)(3) of the Internal Revenue Code of 1988). That determination letter is still in effect.

We classified your organization as a publicly supported organization, and not a private foundation, because it is described in sections 509(a)(1) and 170(b)(1)(A)(vi) of the Code. This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's purposes, character, method of operations, or sources of support have changed, please let us know so we can consider the effect of the change on the organization's exempt status and foundation status.

Your organization is required to file Form 980, Return of Organization Exempt from Income Tex, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth morth after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

As of January 1, 1984, your organization is liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more the organization pays to each of its employees during a calendar year. There is no liability for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes. If you have any questions about excise, employment, or other federal taxes, please let us know.
