Departmental Spotlight: The Division of Public Works' Sign Shop

### Helping you pick the right path countywide

Ever wonder where Sullivan County's 15,000 road signs come from? The guys of our Sign Shop know: they made them.

"We made over 1,000 signs just in January, February and March of this year," notes Charlie Kocher, Sign Shop supervisor.

Fabricator Jerry Sommers had been a Division of Public Works automotive equipment attendant for 13 years before he moved into the Sign Shop. "This is very much unlike anything I did in the beginning," he nods, speaking not only about the switch in career track but the County's new focus on signage far beyond what you'll find on the road.

In fact, the team has been busy creating new signs for the renamed Care Center at Sunset Lake (the Adult Care Center), revamped decals for County vehicles, new Adopt-an-Exit ovals along Route 17, those tiny "No Tobacco Sold to People Under 21" posters found in every smoke shop and gas station for miles around, and a slew of new directional signage in County parks.

"Fort Delaware's our largest sign, at 6x20 feet," says Jerry, who uses everything from paper to vinyl to automotive paint to create a distinctive, noticeable sign.

He shares the Fabrication Room with fellow fabricator Mike Isfan, who got his start with DPW's Road Maintenance crew—and which he sort of never left.

"I still plow snow, load trucks, clean the yard up," Mike affirms, along with being part of the team which stripes 385 miles of County roadways, plus certain towns'.

#### Our WIC Is #1!

Sullivan County's WIC (Women, Infants and Children) Program has been ranked #1 in New York State for providing nutrition services 100% of the time by qualified nutritionists. The ranking was determined by the NYS Department of Health's Division of Nutrition Services, WIC Program.

The program was also recently ranked sixth in the State for the percentage of infants exclusively breastfed at six months, at 21.3%.

Nancy McGraw, the director of Public Health Services (which oversees the local program), credits the hard work of the WIC staff in promoting breastfeeding, quality nutrition counseling, and implementing monthly breastfeeding support groups under the direction and leadership of Lynn Guiser.

### Care Center begins a new era

Legislators and staff of the Sullivan County Adult Care Center gathered under sunny skies May 18 to celebrate the new name, logo and branding of the facility, now known as the Care Center at Sunset Lake (CCASL).

Drawing upon the name of the town road and County-owned lake which sit immediately adjacent, the Care Center at Sunset Lake rebranding is intended to highlight and reinforce the facility's commitment to quality long- and short-term care, comfortable surroundings and compassionate service.

"We realize that even though this is a nonprofit, publicly-operated facility, we are in a competitive environment with other nursing homes and short-term physical rehabilitation centers in the region," noted Sullivan County Manager Josh Potosek. "So we are embarking on a campaign to remind people why selecting the Care Center at Sunset Lake is a wise choice where they can be confident they and their loved ones will receive the treatment they deserve."

The process to find a new name began approximately six months ago, where first staff and then the public were asked for ideas, and over 100 potential names were submitted. A new logo, created by Dorene Warner of Barryville-based W Design, was approved by the Legislature last month.

The Care Center at Sunset Lake remains under County ownership and operation, and in early May, Administrator Frank Murphy received word that the Centers for Medicare and Medicaid Services awarded the facility a full five stars — the highest ranking possible — under its Five-Star Quality Rating System.

"We've hit the high mark – and we aim to stay there, day in and day out," said Murphy. "I encourage everyone to schedule a tour of our facility, where we can prove this ranking in person."

Indeed, the Sign Shop is situated in the heart of DPW's Barryville complex, a staging point for all manner of DPW activities.

The Shop itself occupies two stories of one building, much of it dedicated to storage of signs of every conceivable size, shape and color.


One corner of the Fabrication Room still houses a gigantic baking machine, used to literally cook signs to completion. Nowadays, baking, silkscreening and handpainting have given way to desktop publishing, with signs designed on computers outfitted with CorelDraw, then printed and precisely sliced on large-format plotter-cutters up to 30 inches wide.

"Our biggest leap has been the printer," affirms Charlie, adding with a chuckle, "We should get an even bigger one!"

But making the signs is only half the process. They then must be mounted securely by the installation team of Pat Kerr and Pete Finck.

Then again, they only get their hands on a sign if Jerry and Mike are 100% satisfied.

As Mike puts it, "It will not go out the door if it looks bad."
