### ARTS AND CULTURAL DEVELOPMENT

The arts and cultural activities are an important part of Sullivan County, which have made a resurgence in recent years making it one of the fastest growing industries defining the character of the new Sullivan County. An influx of artists attracted to the area by its natural and scenic beauty, among other factors elaborated below, has contributed to this trend.

The historic Woodstock Music and Art Festival, was held for three days in August, 1969 on a 600-acre dairy farm in Bethel attended by about 500,000 people. It was the most famous rock festival of its era, and continues to draw nostalgic fans and visitors to the site. The Bethel Woods Center for the Arts being developed at the site of the Woodstock Festival is slated to open in 2006.

The Delaware Valley Arts Alliance (DVAA), the arts council for Sullivan County, was founded in 1976 to build collaborations that advance the arts in Sullivan County. Since its founding DVAA has led cultural development through its arts management assistance, umbrella and incubation services and grant programs. The organization also sponsors and hosts art exhibitions, literary events, concerts and festivals which include Jazzfest, an annual tradition held every May for the last 14 years presents live jazz in the Tusten Theater and Riverfest, a music, art and environmental festival held annually in July. The Delaware Valley Opera, a Sullivan County-based opera production company, is in residence at the Tusten Theatre in Narrowsburg, NY in the summer and also perform regionally.

DVAA has been distributing grant funds awarded to local organizations from the New York State Council on the Arts since 1984. A similar Sullivan County grant program was established in 2002. These funds have been integral to the growth of local cultural organizations that have been listed in Appendix 'xx'. Other critical resources for the County arts and cultural assets include 13 libraries, also listed in Appendix 'xx'.

Additionally, it is estimated that over 1,000 individual artists are living and working in Sullivan County. Writers (poets, novelists, and playwrights), book designers, composers, musicians, visual artists and craftspeople (painters, sculptors, potters, metal smiths, etc.) have created studios here. Most of these artists create their work in the County but some of their target markets are outside the County. status while administering the funds locally to build and reinforce art-related activities and cultural tourism in the County.

Currently, good statistics are required to substantiate recent observations of the resurgence of the Arts in Sullivan County and will be generated as per the *Sullivan 2020* strategies described in this section. In addition, these strategies intend to further develop the arts as an industry that promotes cultural and economic development in Sullivan County and will be packaged with other tourism markets to influence longer stays leading to more business, an increase in lodging accommodations and potentially revitalization of resorts.

The Sullivan County Cultural Foundation, a partnership between the DVAA and Sullivan County Visitor's Association, is a non-profit organization established to draw funds because of its tax-exempt
