The Recruit and Retention program is going well, the booth at the bagel Festival produced 30 possible leads. They will also be going to the High Schools in the coming weeks.

The Rehab Team is not up and running as of yet, hopefully sometime this fall. The vehicle has been backordered due to supply issues. Once it arrives we can begin training.

The State still is reviewing the Mutual Aid Plan. The Arson Control Plan will be done soon. Once they are available we will review them here and then pass along to the Public Safety Committee and then the full Legislature.

### **Committee Reports:**

**Arson Task Force**: They have been very busy. The Fraser Road Fire was arson. The fire investigators and the sheriff worked quickly to find the party and make an arrest.

**Radio**: Alex was unavailable tonight. The dispatchers are split between the 911 Center and the State Police in Liberty due to Covid.

The new Verizon tower in Rick Hill probably will not be available until spring due to back ordered equipment.

Pete brought up an issue with ground channels in Rock Hill. John asked that in the future you report the problem so he can go out and recreate the problem and test. In this case and in the case in Lumberland it may have been a user being on scan mode
