

Pistol Permit Pre-approved Coupon Rules

1. Every pistol permit holder in good standing may pre-purchase up to two (2) coupons for the purchase of up to two (2) new handguns within NYS, at any one time, at a cost of \$15.00 per coupon;
2. Each coupon issued by the Pistol Permit Clerk shall be valid for only fourteen (14) days and SHALL expire at the end of fourteen (14) days;
3. The pistol permit holder will not be able to purchase any additional coupon(s) until the fourteen days set forth in paragraph 2 has expired, **and** the applicant has, within seventy-two (72) hours of purchase, returned to the Clerk's office and filled out the amendment form or the unused coupon(s) are returned to the Clerk's office;
4. Upon return to the Clerk's office the pistol permit holder will complete an amendment form and pay the appropriate fee to add any new handguns and provide a copy of the receipt from the dealer listing the make, type, model, caliber and serial number of the handguns purchased and those handguns will then be added to your permit card.
FAILURE TO DO THIS WILL RESULT IN YOUR PISTOL PERMIT BEING SUSPENDED AND ANY HANDGUNS POSSESSED BUT NOT ADDED TO YOUR PERMIT WILL SUBJECT YOU TO PROSECUTION FOR CRIMINAL POSSESSION OF A WEAPON.
5. Once the handgun(s) are purchased **they cannot be carried by the applicant until they have been added to the pistol permit.** The handgun(s) must be taken from the gun dealer location to the permit holder's residence and secured therein until added to the permit;
6. Should you be arrested or charged with any offense after the issuance of any pre-approved coupon all such pre-approved coupons will be VOID upon your arrest or being so charged. Should you utilize any pre-approved coupons after an arrest or being charged with any offense you will be in direct violation of these rules and will be subject to having your pistol permit revoked.
7. Any person using an expired coupon shall be subject to having their pistol permit suspended and revoked permanently;
8. If a pistol permit holder had been issued pre-approved coupons in accordance with this policy and has previously failed to comply with the terms of the coupon policy, the permit holder will be ineligible for the issuance of any future pre-approved coupons.

Notice Pursuant to Penal Law Section 210.45

A person is guilty of making a false punishable statement when he knowingly makes a false statement, which he does not believe to be true, in a written instrument bearing a legally authorized form notice to the effect that a false statement made therein are punishable. Any false statements made herein are punishable as a class A misdemeanor punishable by up to 1 year in jail or a \$1,000 fine or both.

PRE-APPROVED PISTOL PERMIT COUPON PROCESS

1. Make an appointment 845-807-0416
2. Bring your pistol permit and \$15.00 fee for coupon
3. Short wait, receive coupon (expires in 14 days)
4. Once pistol is purchased
 - a. Make an appointment to get new permit
 - b. Bring purchase receipt and old permit card
 - c. Pay \$5 amendment fee plus \$1 for each additional card.
 - d. Walk out with pistol permit with new purchase listed
