**UPON** reading and filing the List of Delinquent 2023 Taxes duly verified on the 1<sup>st</sup> day of November, 2023 and filed November 1, 2023 in the Sullivan County Clerk's Office pursuant to Article Eleven of the Real Property Tax Law of the State of New York, and in particular §1122 thereof, and upon proof of due publication of the Petition and Notice of Foreclosure in the proceeding to foreclose the 2023 tax liens, pursuant to §1124 of the Real Property Tax Law, and upon due proof of the posting of said Petition and Notice of Foreclosure, and upon proof of the due mailing thereof along with the Personal Notice of Commencement pursuant to §1125 of the Real Property Tax Law, and on reading the Affidavit of Regularity of Nancy Buck, Sullivan County Treasurer, sworn to the 10<sup>th</sup> day of June, 2025, showing that the period of redemption has expired and that no Answer has been filed or served;

**AND** the Court having heard the allegations and proof and after due deliberation having been had, and the Court having filed its Decision and Order herein, containing a statement of the facts

found and conclusions of law herein and directing judgment as hereinafter stated;

**NOW ON** motion of the Sullivan County Treasurer, Nancy Buck, it is

**ORDERED, ADJUDGED AND DECREED** that the parcels of property described in said List of Delinquent Taxes for 2023 or earlier, filed herein which since the commencement of this action have been redeemed and for which Certificates of Redemption are being filed in the Office of the Clerk of the County of Sullivan, be canceled from the List of Delinquent Taxes as amended, and it is further

**ORDERED, ADJUDGED AND DECREED** that the parcels of property described in said List of Delinquent Taxes for 2023, filed herein which since the commencement of this action have been withdrawn and for which Certificates of Withdrawal have been filed in the Office of the Clerk of the County of Sullivan, be withdrawn from this proceeding In Rem, subject to reinstatement, and it is further

**ORDERED, ADJUDGED AND DECREED** that all proceedings in this action were fully and properly taken pursuant to Article Eleven of the Real Property Tax Law of the State of New York, and in particular sections 1122, 1123, 1124, 1125, 1127, 1128, 1131, 1136, and 1178 thereof, and there has been full and due compliance with the provisions of said Article Eleven, and it is further

**ORDERED, ADJUDGED AND DECREED** that the County of Sullivan, or its designee pursuant to written agreement, is awarded possession and title of every parcel of land described in the Revised List of Delinquent 2023 Taxes, not heretofore redeemed or withdrawn and as to which no Answer has been interposed, and to which no installment agreement has been entered into, no bankruptcy proceedings have been filed and as contained on Schedule "J" attached to the Notice of Motion dated June 10, 2025, incorporated herein by reference, and all items of personal property

thereon the premises deemed to be abandoned to the County of Sullivan; and the Sullivan County Treasurer, Nancy Buck, the Tax Lien Enforcement Officer of Sullivan County, is hereby directed to make, execute and cause to be recorded a Deed or Deeds conveying to the said County of Sullivan, or to a third party in the discretion of the enforcing officer, if any, full and complete title to the said parcels of land in fee simple absolute, free and clear of all liens and encumbrances pursuant to Real Property Tax Law Article 11, and it is further

**ORDERED, ADJUDGED AND DECREED** The County's responsibility pursuant to Real Property Tax Law §1178 has been satisfied by virtue of its mailing of the pleadings and lists to the New York State D.E.C., and it is further

**ORDERED, ADJUDGED AND DECREED** that the foreclosure of the parcels for which the property owners have entered into an installment agreement with the County pursuant to RPTL §1184, as contained on Exhibit "K" attached to the Notice of Motion dated June 5, 2025, shall continue without interruption, but that the County shall not take title to said properties unless and until the property owner is in default and breach of the terms of the said installment agreements at which time, the County upon notice to the owner by regular first class mail, will apply for separate and independent determinations and a Judgment of Foreclosure pursuant to the terms of said agreement(s), and it is further

**ORDERED, ADJUDGED AND DECREED** that for the six (6) Villages within the County of Sullivan, New York, title to all properties on said Revised List of Delinquent Taxes, lying and being wholly situate within any one of the six (6) Villages are hereby conveyed to the County of Sullivan free and clear of the real property tax liens of said Village, except that title of the County of Sullivan will be subject to the unpaid 2024/2025 and 2025/2026 Village tax liens, the payment of which will be the obligation of the successful purchasers at the County of Sullivan's Public Auction and the respective Village shall be paid their delinquent taxes after the County's unpaid liens are satisfied from the surplus proceeds of the sale, if any; and it is further

**ORDERED, ADJUDGED AND DECREED** that upon the execution and recording of

the Deed(s) hereinbefore directed, the County of Sullivan, (or pursuant to a written agreement, the County's designee) shall be seized of an estate in fee simple absolute free and clear of all liens and encumbrances of those parcels of land therein described pursuant to Article 11 of the Real Property Tax Law, and seized of all items of personal property thereon, deemed abandoned to the County of Sullivan, for separate disposition by the County Treasurer; and all persons, including the People of the State of New York and the United States of America, infants, incompetents, absentees and non-residents who may have had any right, title, interest, claim, lien or equity of redemption in or upon such properties shall be barred and forever foreclosed of such right, title, interest, claim, lien or equity of redemption; however, nothing contained herein shall be construed to preclude any such person from filing a claim for a share of any surplus that may be attributable to the sale of such parcel pursuant to §1135 or Title 6 of the RPTL; and it is further

**ORDERED, ADJUDGED AND DECREED** that for purposes of the United States Bankruptcy Code, title shall be deemed vested in the County of Sullivan upon the expiration of the redemption period as set forth in the published Petition and Notice of Foreclosure, and that the execution of the Enforcement Officer's deed shall be ministerial, and it is further

**ORDERED, ADJUDGED AND DECREED** that the parcels of land to which the County of Sullivan shall receive possession and title, as aforesaid are those as contained on the Revised List of Delinquent Taxes, and as contained on Exhibit "J" attached to the Notice of Motion for Default Judgment, which is incorporated by reference herein.
